Membership Number – This number is assigned to Members and their families, it can be used to register for BNH programs, vote at our AGM or to access personal information on program participation.

Primary Contact E-mail - The primary contact e-mail will be used to deliver "The Buzz" and any additional information requested by BNH members and their families. In the absence of an e-mail contact, information will be mailed to the address of the Member's family.

Use and Storage of Information

Information collected by the Burnaby Neighbourhood House will be used and stored in accordance with our Personal Information Protection Policy, as set out in the Protection of Personal Information Act of British Columbia. Membership forms and information will be held for a period of 12 months after expiry of membership.
